



Business Description

Valuation as of 2 May 2024

Morningstar affirms a 4-star quantitative rating for Braskem. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 3.96, a discount of 38.72% to its Quantitative Fair Value estimate of 6.46. This discount has ranged between 57.99% and 30.65% over the past year. The stock's price to fair value ratio is at the 27th percentile in our global equity coverage universe for this methodology and at the 49th percentile relative to its peers in the basic materials sector.

Braskem furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 04/30/2024, before which it was 3-star. Similarly, the firm's uncertainty rating changed from Extreme to Very High after 04/30/2024.

We examine the financials and market statistics for Braskem to determine these ratings. Its enterprise value-to-market value ratio is 3.42 and its trailing 12-month maximum drawdown is 40.59%. These fall at the 94th and 67th percentiles in the equity universe and at the 95th and 50th in the basic materials sector, respectively.

Economic Moat ^aas of 2 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.76 sits at the 84th percentile in the basic materials sector. This is a decrease from 0.85, the maximum of its moat scores over the past year. The quantitative financial health rating for Braskem

is Moderate. Its financial health score, termed Distance to Default, sits at the 11th percentile in the universe and 10th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Braskem is 23.54%, and its annualized trailing 12-month volatility is 38.97%. They sit at the 23rd and 61st percentile in the global equity universe, respectively.

Fundamentals as of 2 May 2024

The earnings per share for Braskem is -5.75. The company earns a return on invested capital of -3.2%, falling at the 50th percentile in the basic materials sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
