be related to the news, released by the press on 06.18.2024, that the companies

Ternium Investments, Ternium Argentina, Confab Industrial S.A. and Prosid

Investments, which make up the T/T Group in the Company's control block, were

convicted, in a judgment held at the Superior Court of Justice – STJ, to indemnify

Companhia Siderúrgica Nacional – CSN and other vehicles related to it ("CSN") in the

context of a lawsuit filed by CSN against the aforementioned shareholders who are

members of the Usiminas control block, related to the acquisition of an equity interest

in the Company carried out in 2012.

By the way, Usiminas refers to the Press Release released on 06.18.2024 by Ternium

S.A. (https://s2.q4cdn.com/156255844/files/PressReleases/2024/PR-TX-2024-06-

18.pdf).

Usiminas also clarifies that it is not a party to the aforementioned judicial proceeding

and understands that the aforementioned decision does not generate effects for the

Company or for its other shareholders who are not also parties to the judicial

proceeding in question.
